Each bid should indicate the entity responsible for execution on behalf of the team.
3. Return of Response - Complete and return the **Provision Response Form, Exhibit A**. All bids must be submitted via this form. Responses may be mailed, emailed, or hand-delivered as long as they are *received* at DRCOG's office no later than **5:00 p.m. Mountain Time on February 13, 2012**. Only responses received by this deadline will be considered.
4. Experience Summaries - Please provide examples of recent customers your organization has worked with on hardware solutions.
5. References - Please provide us with at least 3 references, preferably recent (within the last 3 years) customers for whom you have provided similar products.
6. Rejection Rights - DRCOG reserves the right to reject all responses and re-solicit if deemed by DRCOG to be in its best interest.
7. Costs of Bid Preparation and Other Charges - No reimbursement will be made by DRCOG for any costs incurred prior to a formal notice to proceed.
8. Request for Bids - All responses to this solicitation become the property of DRCOG upon receipt and will not be returned to the respondent. Selection or rejection will not affect this right. DRCOG shall have the right to use any or all of the ideas or adaptations of the ideas contained in any response received, excluding case study materials or other reference materials prepared for clients of respondent. Any confidential/proprietary information submitted in response to this request shall be readily identified, clearly marked and separated from the rest of the response.
