## **DRCOG Awarded \$1 Million Planning Grant**

- On April 19, 2023, the DRCOG Board voted unanimously to authorize DRCOG as the lead agency and grant recipient for the Planning Grant.
  - \$1 million planning grant awarded on August 1, 2023.
  - Priority Climate Action Plan (PCAP), submitted in April 2024 after DRCOG Board approval.
  - Comprehensive Climate Action Plan (CCAP), due December 1, 2025.
  - Status Report, due August 1, 2027.



## **Planning Grant Deliverables**

- The planning grant funds are designated for the completion of the following products:
  - Priority Climate Action Plan (PCAP), submitted in April 2024 after DRCOG Board approval.
  - Comprehensive Climate Action Plan (CCAP), due December 1, 2025.
  - Status Report, due August 1, 2027.




- •Voluntary, interconnected strategies to cut climate pollution.

# **Chapter 2: Climate pollution emissions inventory**


2022 Regional climate pollution emissions: 43.7 million metric tons of CO<sub>2</sub> equivalency per year






# **Chapter 3: Projections and targets**





# Chapter 6: Public and Stakeholder Engagement

- Monthly Stakeholder Steering Committee comprised of local government staff.
  - 30-60 attendees each month.
- Formed an Equity Subcommittee comprised of leaders representing Community Based Organizations.
  - Incorporated into key decision-making throughout.
- Four virtual public meetings.
- Public Engagement Website.
- Coordination with the Colorado Energy Office.
- Dozens of meetings with individual stakeholders and non-profit groups.
- Formed a Waste Working group to identify new measures.



# **Chapter 7: Workforce**

# SWOT analysis to Colorado's clean energy workforce

#### **Strengths**

- Job demand continues to increase.
- Wide range of jobs with varying levels of education required.
- Diverse career paths with innovation and technology advancements.

#### **Opportunities**

- Upskilling current workforce through DRCOG and other programs.
- Increasing diversity through stakeholder engagement.
- Collaboration opportunities with public-private partners.

#### Weaknesses

- Lack of diversity in workforce (gender, race, age).
- Training and certification programs can be expensive.
- Geographical limitations many trainings are concentrated in urban areas, limiting access.

#### **Threats**

- · High turnover rates across industries.
- Economic volatility could result in federal and state funding cuts.
- Inadequate grid modernization and supply chain disruptions can slow down progress.



## What's next?

- CPRG Planning Grant continues funding a full-time position for two more years.
- Convene with stakeholders after plan adoption to evaluate best use of resources.
- Seize opportunities to expand DRCOG's sustainability work through the Power Ahead Colorado program.



## **Proposed Motion**

Move to adopt the Denver Regional Council of Governments Comprehensive Climate Action Plan to be submitted to the U.S. Environmental Protection Agency by December 1, 2025.
