Amendment of Resolution No. 75, 2025 with Breakthrough Alliance of Colorado changing the term from December 31, 2027, to two years from date of contract execution.

Agenda item type: Consent agenda

Summary

A request to authorize the Executive Director to correct the term of a contract with the Breakthrough Alliance of Colorado from a specified date to a contract term of two years. The scope of the contract is to design and implement a series of HVAC and heat pump trainings for incarcerated individuals nearing reentry.

Background

In 2024, DRCOG received a \$199.7 million Climate Pollution Reduction Grant from the U.S. Environmental Protection Agency to implement a regional building decarbonization initiative. A portion of this award (\$900,000) is dedicated to designing and implementing technical trainings for incarcerated individuals who are approaching release and will be reentering the workforce. This effort is intended to support workforce development in HVAC and heat pump installation, fill regional labor gaps, and expand access to stable, high-demand career opportunities across communities historically excluded from the green workforce.

Through a competitive procurement process conducted in 2025 DRCOG selected Breakthrough Alliance of Colorado to administer the program based on its experience, capability, and partnerships.

The original contract term date was approved for December 31, 2027. Staff is requesting to correct the term to two years instead of a specific date to account for the time needed to execute the contract. A contract Not to Exceed limit of \$900,000 is unchanged.

Resolution authorizing the Executive Director to increase the City of Boulder's subaward contract by \$300,000 in a total amount not to exceed \$1,500,000 with a term ending September 30, 2029.

Agenda item type: Consent agenda

Summary

Increase City of Boulder's Building Policy Collaborative allotment by \$300,000 to correct a formula error in the original allocation. City of Boulder's correct allotment will be \$1.5 million.

Background

In October 2024, DRCOG received a \$199.7 million Climate Pollution Reduction Grant from the U.S. Environmental Protection Agency to develop and implement a regional Building Decarbonization Program. A \$39 million component of this program, the Building Policy Collaborative (BPC), supports jurisdictions across the region in adopting and implementing above-code energy policies including performance standards, equipment standards, permitting reforms, and related initiatives.

As part of the Building Policy Collaborative, DRCOG is distributing \$34.8 million in formula-based subawards to eligible jurisdictions through round one of a two-round process. The City of Boulder is requesting their allotted formula to increase local staffing capacity, update their existing building policies to have their BPS cover smaller buildings, create an equipment standards policy, and create resources for existing buildings owners complying with these policies.

DRCOG staff received Finance and Budget Committee approval on December 3, 2025 for a \$1.2 million contract with Boulder, but later determined Boulder's correct formula allotment was \$1.5 million.

Whereas, DRCOG received a \$199.7 million grant from the U.S. Environmental Protection Agency's (EPA) Climate Pollution Reduction Grant program to implement a regional building decarbonization initiative; and

Whereas, within this larger program lies the Building Policy Collaborative (BPC), includes \$34,800,000 USD to support jurisdictions by providing subaward funding for new staff capacity, providing training and professional development related to decarbonization policies, enhancements to permitting processes, technical assistance on policy development and adoption, community engagement support, and any other activities designed to reduce climate pollution from the building sector; and

Whereas, Finance and Budget Committee approved on December 3, 2025 a \$1.2 million contract with City of Boulder, but DRCOG staff later determined City of Boulder's correct formula allotment was \$1.5 million;

Now, therefore, be it resolved that the Finance and Budget Committee authorizes the Executive Director to increase the City of Boulder's subaward contract by \$300,000 in a total amount not to exceed \$1,500,000 with a term ending September 30, 2029.

Amendment of Resolution No. 6, 2026 with Lutheran Family Services Rocky Mountains changing the term from January 31, 2028, to two years from date of contract execution.

Agenda item type: Consent agenda

Summary

This request is to correct a contract term with the Lutheran Family Services Rocky Mountains from a specific termination date of January 31, 2028 to a term length of two years from date of contract execution. The scope of the contract is to deliver a series of HVAC & heat pump trainings to young adults (18-24 years of age) for the building decarbonization program.

Background

In 2024, DRCOG received a \$199.7 million Climate Pollution Reduction Grant from the U.S. Environmental Protection Agency to implement a regional building decarbonization initiative. A portion of this award, \$900,000, is dedicated to designing and implementing a series of HVAC & heat pump trainings to young adults. This effort is intended to support workforce development in HVAC and heat pump installation, fill regional labor gaps, and address the fact that the trades are overwhelmingly aging out of the industry. Investments in the workforce for tomorrow are essential.

Subsequent to a competitive procurement process, Lutheran Family Services Rocky Mountains was selected as program administrator to deliver industry-recognized HVAC and heat pump training that equips young adults for entry-level positions in the decarbonization and building trades sectors. The contract for this work will be funded through the Environmental Protection Agency's Climate Pollution Reduction Grant.

The original contract term date was approved for January 31, 2028. DRCOG staff is requesting to correct the term to two years instead of a specific date to account for the time needed to execute the contract. A contract Not to Exceed limit of \$900,000 is unchanged.
