Welcome and introductions

Douglas W. Rex, standing in for the Chair of the Advanced Mobility Partnership Executive Committee who was unable to attend, welcomed attendees to the Advanced Mobility Partnership Executive Committee meeting.

Website update

Emily Lindsey, Chair of the Advanced Mobility Partnership Working Group, gave an update on the status of the website content migration, from the standalone Advanced Mobility Partnership website to a page on the DRCOG agency website. All associated documents were remediated and shared on the DRCOG site, where materials and information will remain as the standalone domain expires.

Advanced Mobility Partnership Working Group updates

Ms. Lindsey gave an update on the topics discussed during the working group meetings. The working group continues to meet every other month as a forum for coordination, informational briefings and discussion on transportation technology related efforts. Since June 2024, the working group has discussed a variety of topics including: microtransit, mobility hubs, and transit-supportive efforts like first-and-last mile coordination and transit-oriented development.

Areas for coordination

Ms. Lindsey highlighted several areas for coordination among Advanced Mobility Partnership agencies. The areas for coordination included: implementation of the Denver Regional Council of Governments' Innovative Mobility Set-Aside projects and coordination as many regional partners continue to plan for, launch and operate microtransit services. Charlie Stanfield, RTD's primary AMP Working Group representative, noted that the discussions have been helpful and that RTD is willing to convene stakeholders to discuss goals and coordination opportunities.
